SVCA's annual budget process ensures a consolidated picture of Association finances.

- The process begins when SVCA Department Managers conduct an annual asset inventory and inspection, then submit input on the scope and schedule of repairs/replacements.
- Projected revenues are then calculated, taking into account the prevailing economic conditions and regional market trends.
- The Finance Director, and General Manager consolidate management input with market information and prepare a draft budget.
- The proposed budget is then presented to a joint meeting of the Finance Committee and Board of Directors.
- Next, the revised budget is presented to the community at a Town Meeting.
- The Board then reviews and approves the final revised budget, which is presented for a vote of the membership during the annual election.

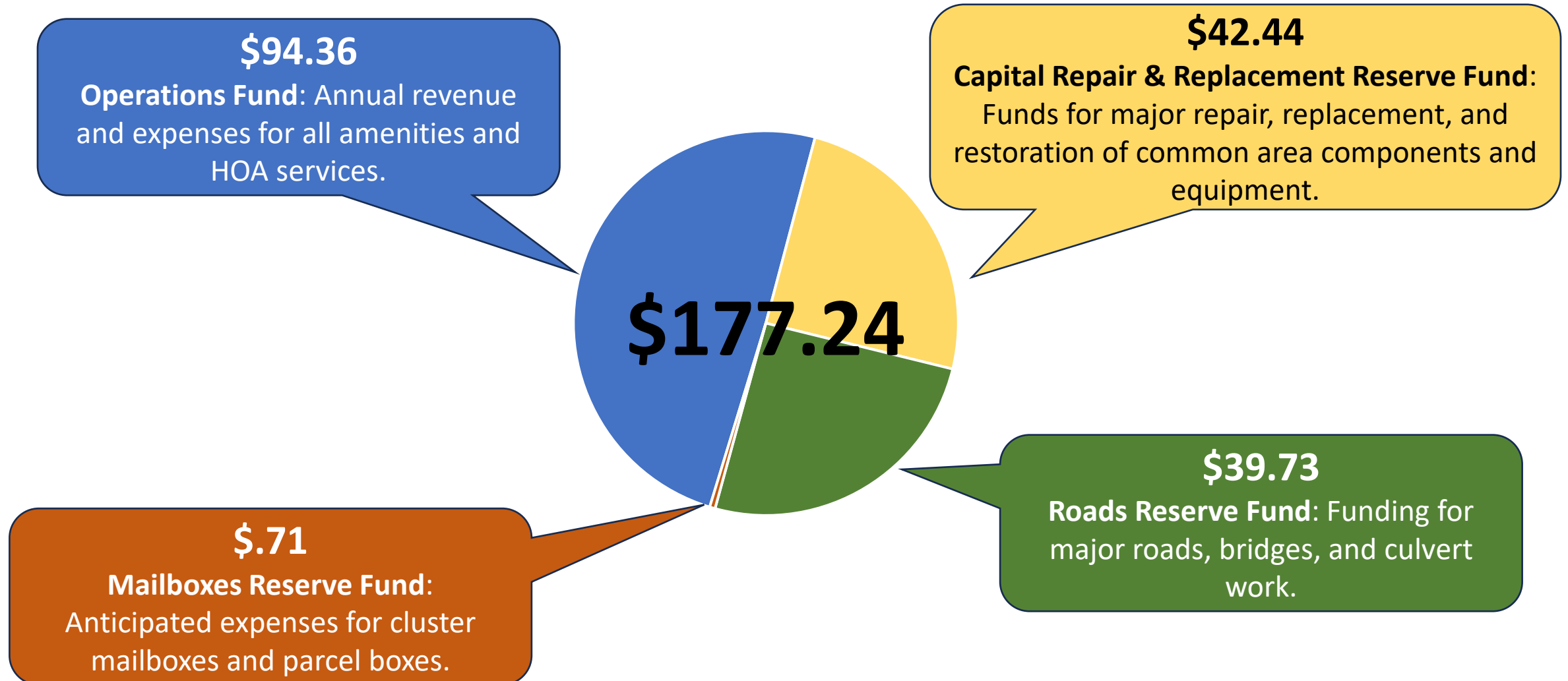


Sudden Valley's operating budget for 2027 balances \$5,485,357 in revenues with \$5,485,357 in expenditures.

Annual Revenue Worksheet

Between 2020 and 2027, proposed annual dues for a developed lot will increase by a total of 22.8%, from \$144.31 in 2020 to \$177.24 in 2027.

If the dues rate had increased at a constant 3% every year beginning in budget year 2021, dues would equal \$177.48 in 2027, just over the proposed amount.

Between 2020 and 2026, the effects of general inflation produced a cumulative price increase of approximately 29%, which is 4.34% per year.

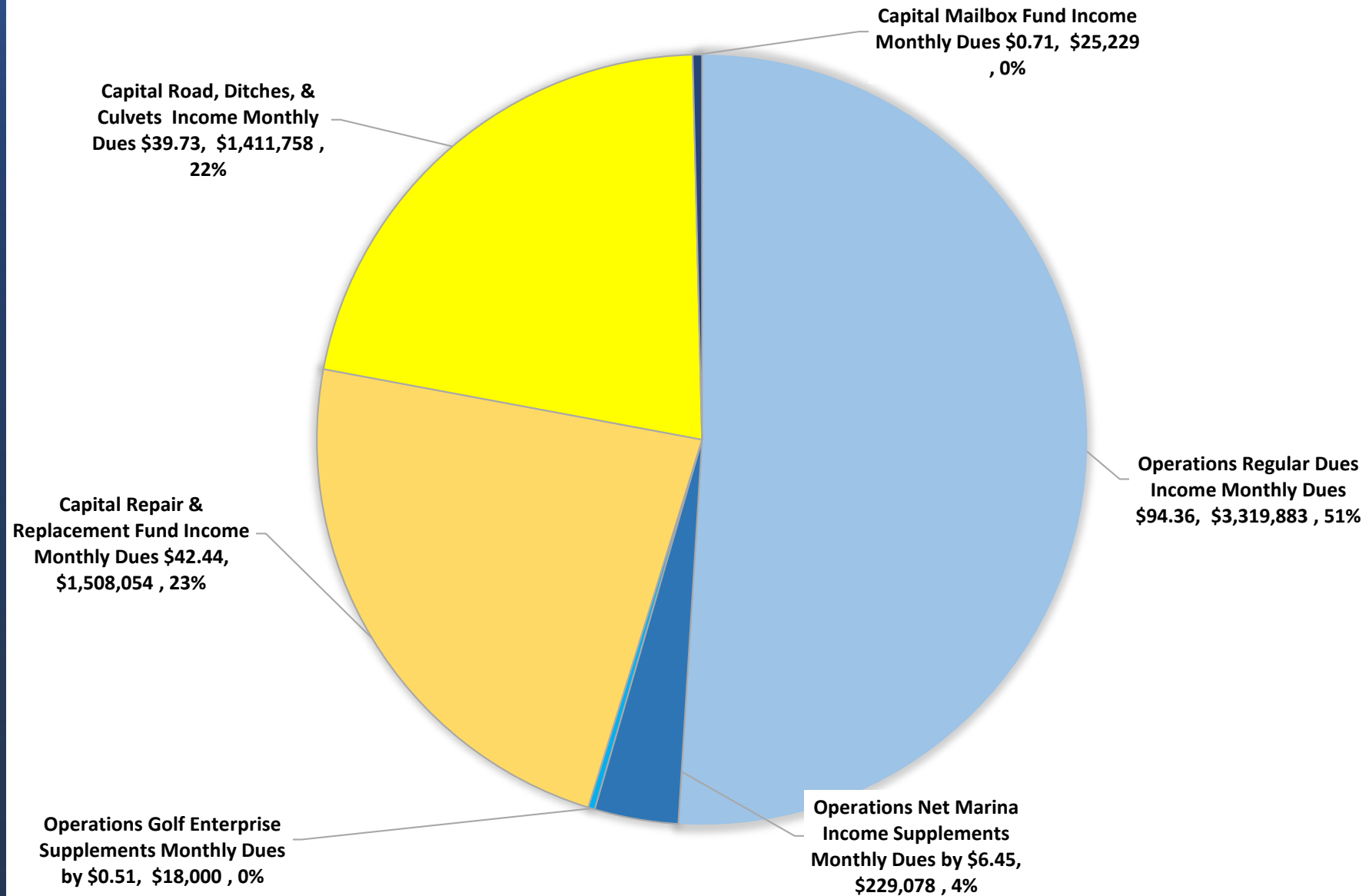

BASED ON 95% COLLECTIONS- 2,792 DEVELOPED LOTS & 325 VACANT LOTS



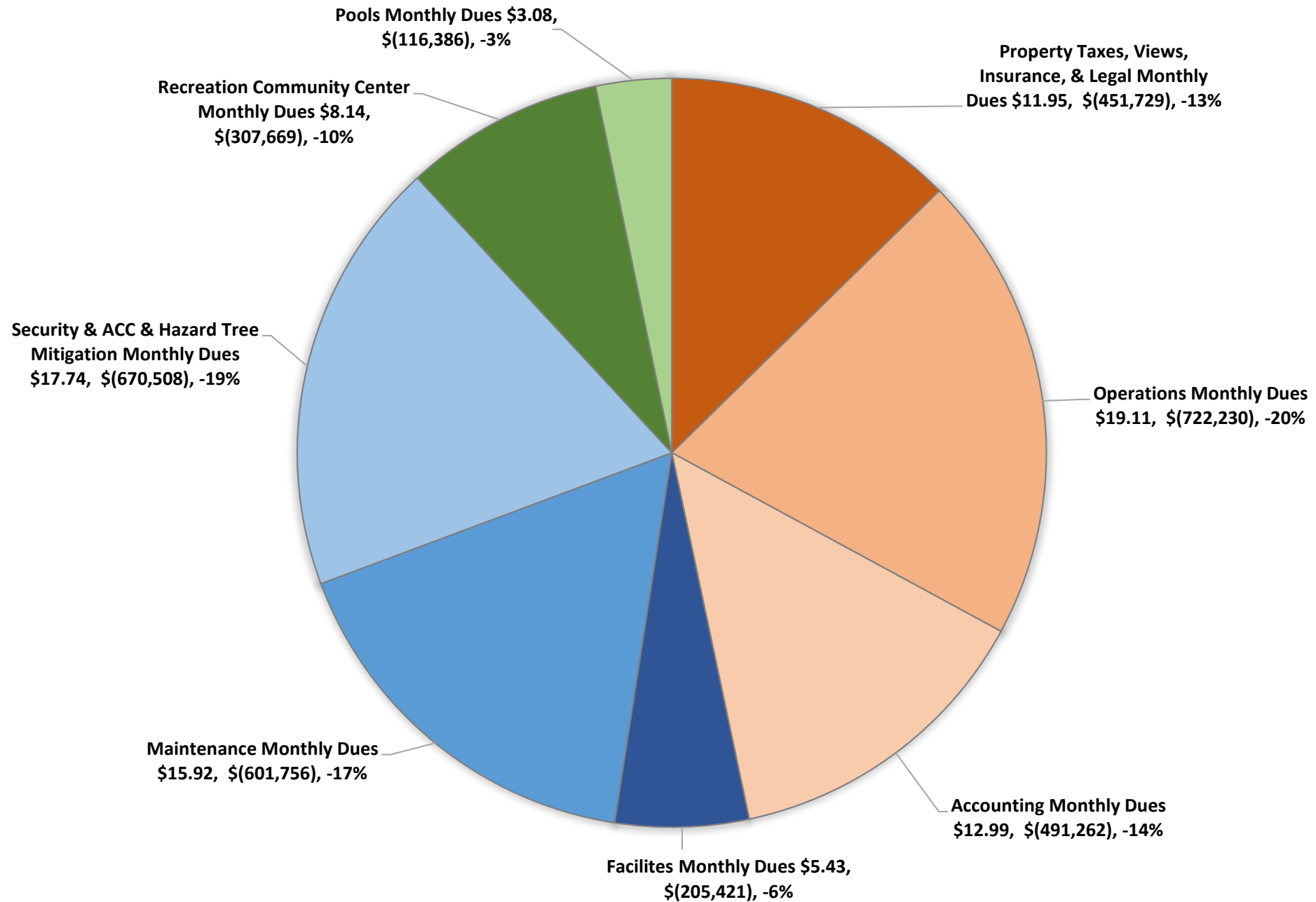

2027 Operating Budget Background

- Current economic conditions are reflected in the 2027 budget draft. Specifically, expected increases in property taxes, insurance, medical insurance, fuel, and utilities were accommodated.
- Additionally, the cost of providing 24/7 security services has increase by about 11% for 2027.
- Three-quarters of the funds collected because of the proposed dues increase of 6% will be used to fund increases in the Operational budget.

Staffing

The 2027 budget reflects a reduction of .48 FTEs.

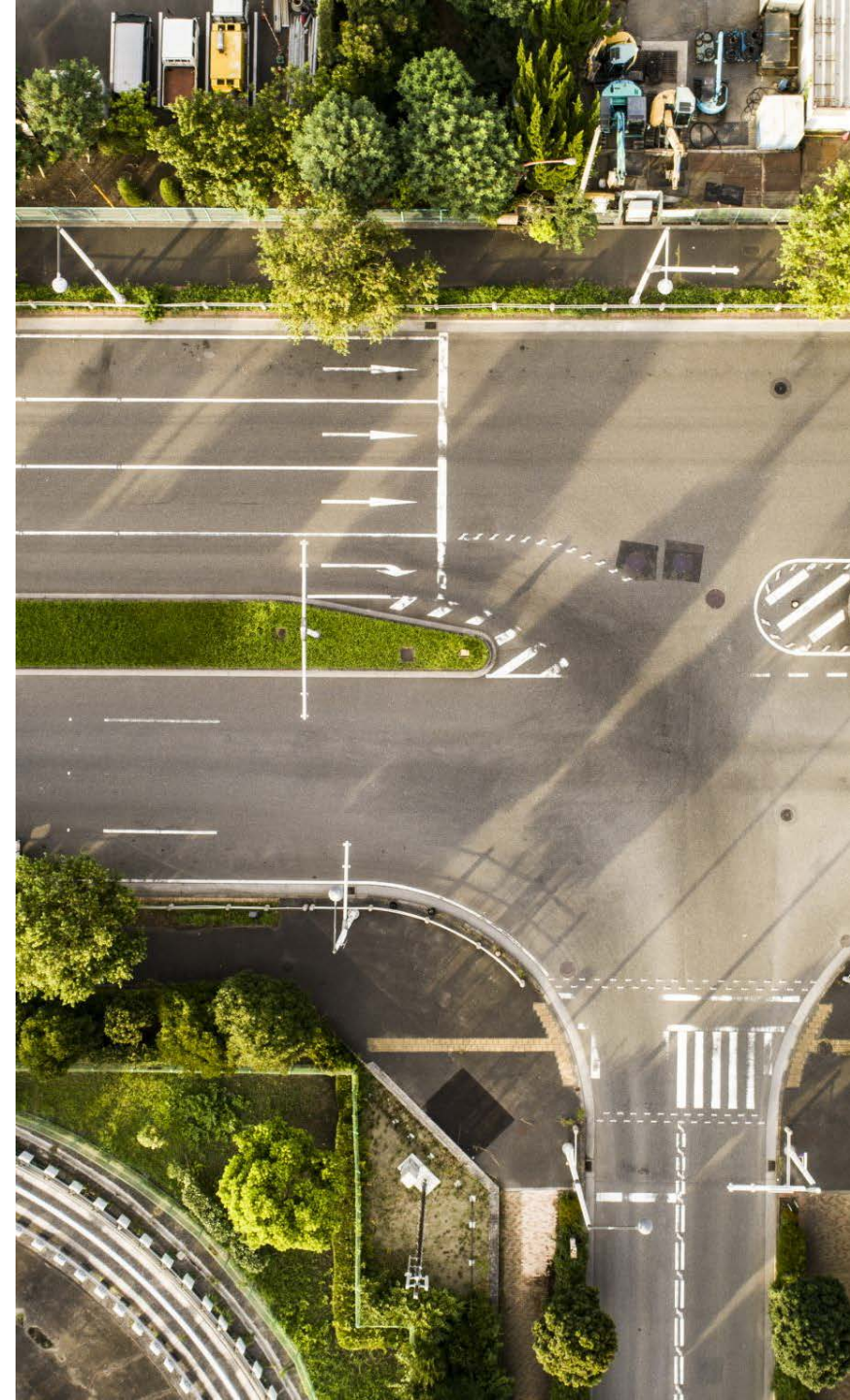

- The Capital Budget is a complex, multi-year projection that models current fund reserves, obligated funds, planned income, anticipated project loan funding, and budgeted expenses.
- SVCA's Capital Repair Replacement Reserve Fund (CRRRF) budget includes the Association's facilities and equipment. The Roads Reserve Fund covers our roads, bridges, and culverts.
- SVCA's capital funds include the Mailbox Reserve, but no spending is planned to draw on that account in 2027.

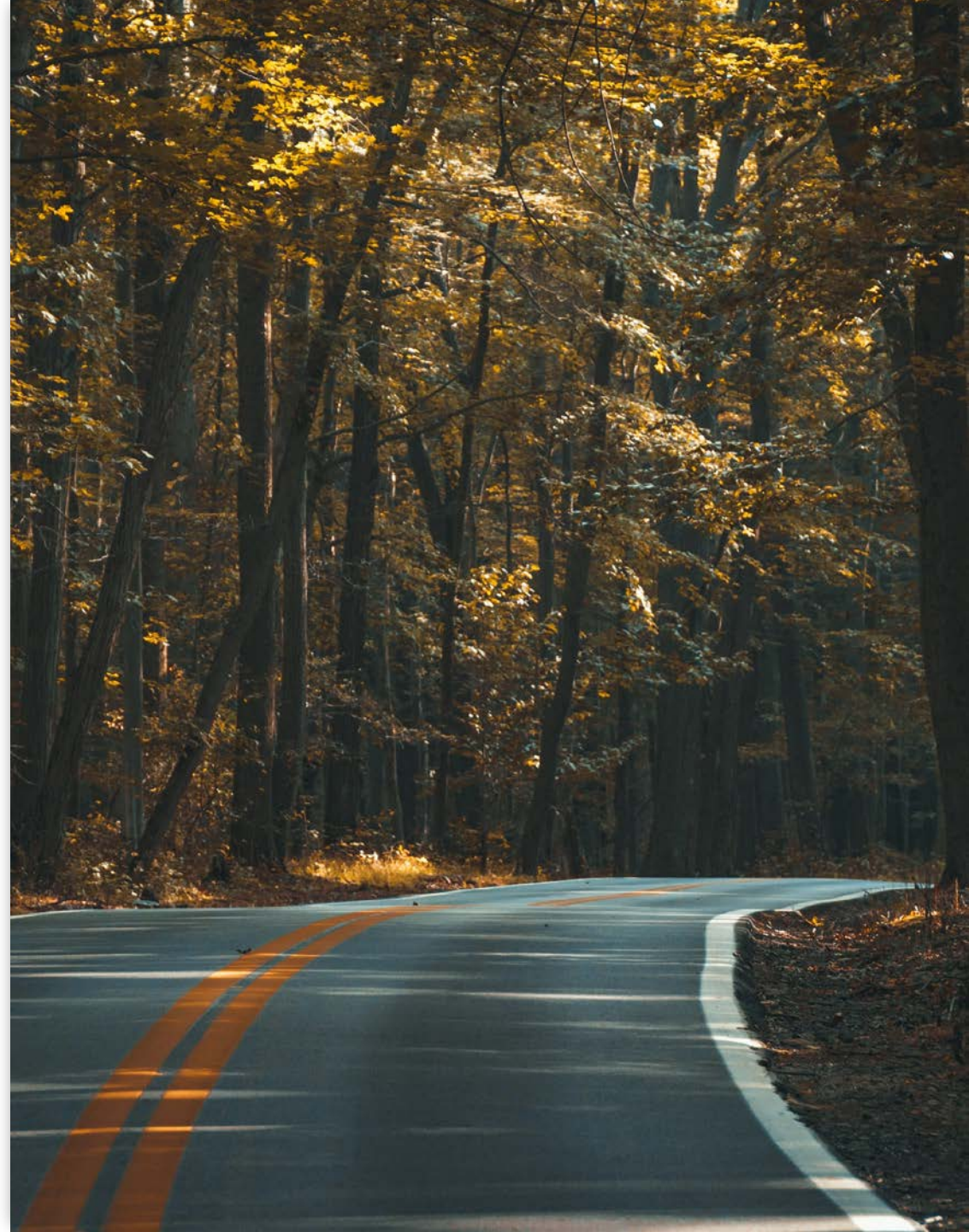

- In February of 2023, the Board awarded a contract to Impact Design for the development of a ten-year maintenance plan for SVCA's roads, culverts, and bridges. This comprehensive plan was presented to the Board in January 2024.
- The plan includes a prioritized list of projects by year, along with estimates of the cost of each project, which the 2027 Roads Capital Budget applies an increase to at an inflation rate of 4% per year.
